Is Our Drinking Water Safe?

Where Does Our Water Come From?

Our well pumps from the shallow unconfined Claibourne Aquifer. The Claibourne Aquifer ranges in depth from 75 to 90 feet below ground level.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in the water source before we treat it include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wild life.

Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by –products of industrial processes and petroleum production, and can also, come from gas stations, urban storm runoff and septic tanks.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.

Radioactive contaminants can be naturally occurring or can be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Tests for the regulated and unregulated contaminants in our Drinking Water Reports show no contamination.

Our water system strives to maintain the highest standard of performance and quality possible. In order to maintain a safe and dependable water supply we sometimes need to make improvements that will benefit our entire community. The costs of these improvements may be reflected in your water rate structure. LEAD

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Plains is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Definitions of Terms and Abbreviations Used in this Report

Maximum Contaminant Level (MCL): “The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.”

Maximum Contaminant Level (MCLG): “The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.”

Action Level: “The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.”

Maximum Residual Disinfectant level (MRDL): “The highest level of a disinfectant allowed in drinking water. There is convincing evidence the addition of a disinfectant is necessary for control of microbiological contaminants.”

Maximum Residual Disinfectant Level Goal (MRDLG): “The level of a disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of disinfectants to control microbial contaminants.”
